Approval of the March minutes: Alice motioned to approve the minutes as stands, Mike seconded, all approved.

#### Old Business:

- April 28 election and open play The online registration form was completed and launched. Online election of officers for the Jefferson City Pickleball club ends at midnight on April 27th. Paper ballots will be available at our April 28th meeting and open play at Lincoln courts beginning at 5:00 PM for members who have not had a chance to vote. Results are being sent to a private email to keep results private and secure. Results will be tallied and turned over to the secretary.
- May Pickle-Dilly The registration site has been created and launched. We have over 60 entries already. The Flyer has been sent out. May 8<sup>th</sup> is the last day for registration if they want t-shirts. We may have to reconsider the rainout days, because the following weekend is the Show-Me Games. Currently we have 35 sponsors. Janet Bloemke and Carol Oetting have agreed to help with the tournament again. Thanks to all who are helping. We will need to keep the banner deadline in mind. We are hoping the event will be at Washington Park courts and the concession stand will be open.
- The Spring Ladder League starts Thursday, April 24th. We have 75
  players. Play will start at Lincoln and hopefully get moved to Washington
  Park when the courts are repaired.
- April 12 social event with Columbia had 56 signed up and it was a nice event. Next year it is suggested the rounds are played 4 on 4 off.
- Online Marketplace Due to lack of usage and it is a lot of work to keep updated, the Marketplace will be removed from the website. Alice made the

- motion, Mike seconded, all approved. If someone has a pickleball item for sale they can list it on the Facebook page.
- Member Appreciation Day Jane will set up a Saturday date in mid to late
  July for the BBQ to introduce the new board and committee leaders, report
  on the year-end financials, and plan the following year's activities.

### **New Business:**

- 1. We hope to submit By-laws changes to the club members in July with an August target date for vote, possibly taking effect in December or next July. Cathy will inform members by email that we are working on changes to the by-laws. What was set up when we had 50 members needs revision now that we have almost 300 members. The by-laws committee consists of Doug Blaha, Mike Bloemke and Dennis chairs the committee. We will survey members for their input, we also ask the board to email JCPBC any items you think should be addressed.
- 2. Website and its future upkeep information by Karen Wisch was discussed with no decision made. Right now, we use (GoDaddy) WordPress, which is like renting a small apartment limited space, fewer options, and less control. By switching to WordPress.org and hosting our site on a server, we'd be moving into a house we own more space, more freedom, and better performance. A server is like a powerful computer that stores our website and sends it to people when they visit. A good server equals faster loading, fewer issues, and better experience for visitors. Why Switch to a Paid Version of WordPress?
  - Speed: A server is faster than WordPress's basic plan our website will load quicker, which keeps visitors engaged.
  - Resources: We get more storage, power, and flexibility to grow our site.
  - Cost-effective: \$145 for 4 years of hosting. After that, it's about \$450 for the next 4 years still cheaper than most.
  - Full control: With WordPress.org, we can install any plugin or design we want — no limits. Bonus: If we were paying a developer to host and manage everything, it could cost \$300 per year or more. By finding a server ourselves, we save money and get better performance.
