Player Development committee: Dennis Gragg

- We have had one session of June's Intro to Pb. Week One was rained out. Our make-up session is scheduled on July 1. We have 26 students enrolled.
- We were challenged to fill all the coaching slots. Most volunteers had limited availability. I ended up recruiting about 18 different people to fill all the needed slots during the four-week class. This includes five non-members of our club. I think we will be able to recruit at least three to become members.
- The Mini-Ladder League for Beginners may be set up inside due to the very warm weather in the forecast.
- Dennis is researching the use of a different type of ball for use with Erne. The Franklins create a lot of dust in the machine and makes cleaning extra time consuming. He has read that the Erne balls and the Selkirk S1 balls are not shredded by the machine as easily. The Erne balls are about \$150 for 50 balls, whereas the Selkirk balls are about \$225 for 100 balls. Kevin may have access to a discount of 150 balls.
- In the works there is a monthly drill session with Mary Ulm. Aiming for 16 participants on 6 courts and 8 participants on 4 indoor courts.
